MILEAGE FEES

FEES CHARGED BY THE MESA COUNTY SHERIFF'S OFFICE RELATING TO THE SERVICE OF PROCESS PURSUANT TO 2010 AMENDMENTS TO §§ 30-1-104, 30-1-105.5, 30-1

In accordance with the provisions of §§ 30-1-104, 105.5, 106, and 116 C.R.S., as amended, fees collected by the sheriff or his/her designated representatives, for serving and returning various writs and processes and performing other duties under state law shall be fixed as follows:

Mileage on all **Civil** Matters: ZONE 1: \$ 7.50 (per attempt)

ZONE 2: \$33.00 (per attempt)

Mileage on all **Criminal** Matters: ZONE 1: \$ 7.05 (per attempt)

ZONE 2: \$31.02 (per attempt)

ZONE 1 includes: Palisade, Clifton, Whitewater, Grand Jct., Fruita and Loma

ZONE 2 includes: DeBeque, Mesa, Molina, Collbran, Mack, Gateway and Glade Park.

It is the customer's responsibility to inform the Sheriff's Office Civil Unit of the number of attempts you are requesting for each paper to be served and submit the appropriate fees. Please call (970) 244-3521 if you are unsure of the correct amount to send.

TWO OR MORE PAPERS SERVED ON THE SAME PERSON OR DIFFERENT PERSONS AT THE SAMETIME AND PLACE IN SAME ACTION:

§§30-1-105.5(1) - the Sheriff shall charge the highest individual fee allowable for the first process, and an additional ten dollars for each subsequent process served on the same person, or served papers on different persons at the same time and location in the same action.

§§30-1-105.5(2) – the Sheriff shall charge the single zone-based mileage fee for the first process, and an additional ten dollars for each subsequent process served on the same person, or served papers on different persons at the same time and location in the same action.
